



# Land of OZ – Maui LLC

## Daycare Service Agreement

**This agreement is entered into by and between Land of OZ – Maui LLC (referred to as “Land of OZ”) and \_\_\_\_\_ (referred to as “Owner”).**

Owner understands and agrees that Land of OZ will be periodically requesting proof of current vaccination records, Bordetella, flea, tick, and heartworm while Owner’s dog(s) is/are attending Land of OZ. \_\_\_\_\_ (initials).

Owner understands and agrees that Owner is solely responsible for any harm caused by Owner’s dog(s) while Owner’s dog(s) is/are attending Land of OZ. \_\_\_\_\_ (initials).

Owner understands and agrees that Owner’s dog(s) will at all times while attending Land of OZ have current vaccination status. Owner further understands that even if Owners’ dog is vaccinated for Bordetella (Kennel Cough) there is a chance that the Owner’s dog(s) can still contract Kennel Cough. Owner agrees that Owner will NOT hold Land of OZ responsible if Owner’s dog(s) contract(s) Kennel Cough. \_\_\_\_\_ (initials)

Owner understands and agrees that during normal dog play, Owner’s dog(s) may sustain injuries. All dog play is carefully monitored by Land of OZ to avoid injury, but scratches, punctures, torn ligaments, etc. may occur even under the best supervision. \_\_\_\_\_ (initials).

Owner understands and agrees that in admitting Owner’s dog(s) to Land of OZ, Land of OZ is relying on Owners representation that Owners’ dog(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any other dog or person. \_\_\_\_\_ (initials).

Owner further understands and agrees that neither Land of OZ nor any of its employees will be liable for any illness, injury, death, and/or escape of Owner’s dog(s) provided that reasonable care and precautions are followed. Owner hereby releases all of them of any liability of any kind whatsoever arising from or as a result of Owner’s dog(s) attending or participating at Land of OZ. \_\_\_\_\_ (initials)

Owner further understands and agrees that any behavioral or health problems that develop with the Owner’s dog(s) while at Land of OZ will be handled and treated as deemed best by the employees of Land of OZ, in their sole discretion, and Owner expressly agrees to assume full financial responsibility for any and all expenses arising or relating thereto. This includes aggressive or destructive behavior. \_\_\_\_\_ (initials)

Owner further understands and agrees that Owner’s dog(s) is/are required to be spayed/neutered after the age of eight (8) months to enroll at Land of OZ. \_\_\_\_\_ (initials)

Owner understands and agrees that Land of OZ reserves the right to use a muzzle or gentle leader if Owners’ dog(s) creates a disturbance to the neighborhood. \_\_\_\_\_ (initials)

Owner further understands and agrees that it is the Owners responsibility to leave an adequate supply of food and medications for Owners’ dog(s) during the entire time Owners’ dog(s) is/are cared for by Land of OZ. Should the food/medication supply need replacement, Owner authorizes Land of OZ to purchase replacement and Owner will reimburse Land of OZ for cost plus a \$25.00 replacement fee, per occurrence. \_\_\_\_\_ (initials)

Owner further understands and agrees that Owners’ dog(s) will have access to a fenced outside area. Owner agrees to assume full liability if Owners’ dog(s) escapes. \_\_\_\_\_ (initials)

Owner further understands and agrees that if Owners’ dog(s) is/are not picked up by the end of the Land of OZ regular business day, then Owner hereby expressly authorizes Land of OZ to take whatever action is deemed necessary for the continuing care of Owners dog(s). Drop offs and pickups outside of normal business hours (7:00am – 5:15pm) will be assessed a fee of \$1.00 per minute. \_\_\_\_\_ (initials)

Owner further understands and expressly agrees that each and every foregoing provision contained in this Service Agreement shall be in force, effective and shall apply to each and every occasion on which Owner boards or deposits Owners dog(s) with Land of OZ. This agreement shall remain in full force and effect between the parties until and unless otherwise cancelled or superseded by a writing signed by the parties. \_\_\_\_\_ (initials)

Owner hereby certifies that Owner has read and understands these rules and regulations set forth above, and that Owner has read and understands this Agreement, and each of its terms and conditions, and agrees to abide and be bound by these rules and regulations.
